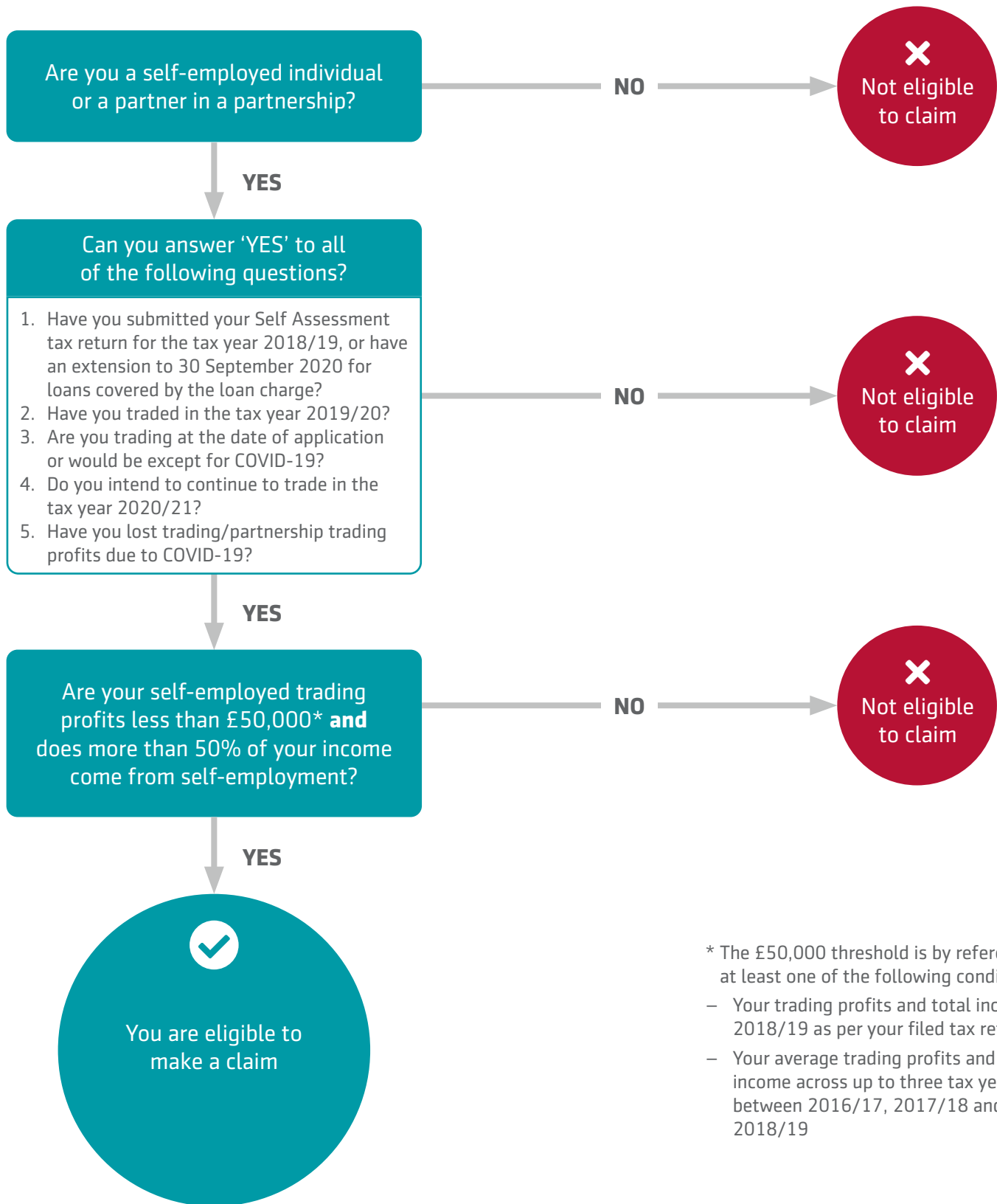


Self-employment Income Support Scheme ('SEISS')
